

### SPECIFICATIONS AND INSTALLATION

The VR1 wall panel control is designed to fit into a 35mm deep, standard single-gang UK electrical wall box, such as a light switch recess, and secured with two screws.

- Height, depth and width specifications are shown below
- Screen: Colour 128x128 pixel LCD
- Controls: 3 illuminated push buttons and 1 rotary control
- Connection: Standard RJ45 Ethernet port, requiring 48V PoE (Power Over Ethernet)

NOTE: We have tested the VR1 with a Netgear GS108PE and recommended the use of this PoE router.



### SETTING UP THE VRI

To set-up the VR1, a computer running either Microsoft Windows or Apple Mac OS with D-Net installed, will be required, along with a network switch / router, capable of providing PoE (Power Over Ethernet) and CAT5 (or greater) Ethernet cable.

D-Net is available to download from the NST Audio website: nstaudio.com/software-downloads

Save the downloaded file to a known location on your computer and install the software from there by double-clicking on it. Your computer may warn you or ask you about running the installation file - accept / ignore any warnings! Windows user should select the 'More Info' link from within the warning dialogue box to proceed. Read and follow the on-screen instructions to complete the installation. Various shortcuts will be placed on your computer allowing you to launch the software from there.

The iPad version of D-Net is available from the Apple app store. (There is a link to this from the software page URL shown above).




If you are unfamiliar with the D-Net software, a user manual is available to download, in PDF format, from the NST Audio website.

NOTE: The remainder of this manual presumes you have some prior knowledge of using D-Net

### CONNECTING TO THE VRI

Once everything is connected and online, the VR1 remote will appear alongside the other NST Audio processors on the network, in D-Net's 'Virtual Rack', as shown in the example below:



To access the VR1's control panel, simply double click / tap the VR1 device on the left. This will open the VR1's control panel, to allow initial set-up or editing of an existing device.

### VRI CONTROL PAGE OVERVIEW

The initial VR1 control page will look similar to the example below – More options will appear upon adding Pages:

**Device Name:** Double click the device name to rename the VR1.

**ID Button:** Press to make the physical VR1 panel flash for five seconds.

This feature is useful for visually identifying a VR1 remote if more than one is installed in the same venue.

**Set Bitmap Button:** Allows a custom picture or logo to be sent to the VR1, which will be displayed on power on and before standby mode is entered. The file must be in Bitmap (\*.BMP) format, and be 128 pixels in height by 128 pixels in width.

Add Preset Recall Button: Press to add a preset recall control page to the VR1.

Add Gain Change Button: Press to add a gain control page to the VR1.

Add Routing Change Button: Press to add a routing change / mute control page to the VR1.

Add Source Select Button: Press to add a set of source selections on a single control page to the VR1.

Delete Page Item Button: Press this button to delete the currently selected / highlighted page.

**Rename Page Item Button:** Press this button to rename the currently selected / highlighted page. Alternatively, a page can be double clicked to rename it. Press Enter or Return, on the computers keyboard, to confirm the change.

Pages Window: Shows the various pages, which have been created, and will be displayed on the VR1's LCD screen.

Page Contents Window: Shows the various parameters contained within the currently selected page.


Available Parameter Window: Shows the parameters available that can be added to the currently selected page.

Add / Remove Buttons: These buttons add or remove parameters from the page contents window.

NOTE: If a new VR1 firmware update is available, a button stating this will appear under the Set Bitmap button. Press this button to update the firmware, in the connected VR1, and follow the on-screen instructions.

### Add Preset Recall:


Press this button to create a preset recall page.

Press the Rename Page Item button to rename the currently selected / highlighted page. Alternatively, a page can be renamed by double clicking on it, in the left-hand Pages window. Press Enter or Return, on the computers keyboard, to confirm the change.

Available presets, from all devices, will be shown in the Presets Available Window. Select a preset to be included in this page and use the Add/Up button to add it. The preset will then appear in the Page Contents window above.

Add additional presets, from other devices, by repeating this process.

All presets contained within the Page Contents window, will recall simultaneously, from a single page shown on the VR1's display.





### Add Gain Change:

Press this button to create a gain change page.

Press the Rename Page Item button to rename the currently selected / highlighted page. Alternatively, a page can be renamed by double clicking on it, in the left-hand Pages window. Press Enter or Return, on the computers keyboard, to confirm the change.

Available channel gains, from all devices, will be shown in the Gains Available window. Select a channel to be included in this page and use the Add/Up button to add it.

The gain parameter will then appear in the Page Contents window above.

Add additional channels, from other devices, by repeating this process.

All gain parameters contained within the Page Contents Window, will adjust simultaneously, from a single page shown on the VR1's display.

NOTE: Use the Min / Max gain options, to set an allowable minimum and maximum gain.

### Add Routing Change:


Press this button to create a routing change / mute state page.

Press the Rename Page Item button to rename the currently selected / highlighted page. Alternatively, a page can be renamed by double clicking on it, in the left-hand Pages window. Press Enter or Return, on the computers keyboard, to confirm the change.

Available parameters, from all devices, will be shown in the Mutes Available window. Select a routing or mute section to be included in this page and use the Add/Up button to add it. The parameter will then appear in the Page Contents window

above.Add additional parameters, from other devices, by repeating this process.

All parameters contained within the Page Contents window, will adjust simultaneously, from a single page shown on the VR1's display.





### Add Source Selections:


Press this button to create a set of source selections on a single page.

Press the Rename Page Item button to rename the currently selected / highlighted page. Alternatively, a page can be renamed by double clicking on it, in the left-hand Pages window. Press Enter or Return, on the computers keyboard, to confirm the change.

Start by creating the list of possible source selections you want on the page (max 4 per page) in the "Source Select States" window.

For each Source Select State, choose the outputs which will change and choose the matrix outputs to unmute for this state (all other matrix feeds will automatically be muted). Repeat the process for each Source Select State.

All parameters contained within the Page Contents window, will adjust simultaneously, from a single page shown on the VR1's display.





**Set Bitmap Button:** Allows a custom picture or logo to be sent to the VR1, which will be displayed on power on and for the period after the screensaver timeout has expired (user defined). The file must be in RGB Bitmap (\*.BMP) format, and be 128 pixels in height by 128 pixels in width.



### PHYSICAL VRI CONTROLS



Once the VR1 has been set-up, using D-Net, the panel is operated by using the three illuminated push buttons and the single rotary control.

The left and right hand buttons move between the parameter pages available – The LCD screen will display arrows above these buttons, showing other pages are available to view.

The centre button is used to confirm choices, such as recalling a preset – Again, the LCD screen will display a message above this button, stating what its function is on the current page.

NOTE: If nothing is shown on the LCD above a button, then that particular button has no function on the current page.

The brightness of the display can be adjusted by accessing the 'Info' page.

To do this, press both outer buttons simultaneously – The panel will then show device information and allow the brightness to be adjusted, using the rotary control.

To exit the Info page, simply press either of the outside two buttons.

NOTE: The VR1 will go into standby mode, when it is not being used. The device is functioning perfectly normal, and will immediately 'wake-up' when up when any control is used. This feature is designed to save power, and also to extend the life of the LCD display and LEDs.

### FAQS (FREQUENTLY ASKED QUESTIONS)

### What is PoE or Power Over Ethernet?

- PoE is a system that passes electric power, along with data, on standard twisted pair Ethernet cables. This allows a single cable to provide both a data connection and an electric power source, from a PoE capable network router or switch, to VCP devices.

### There are lots of standards for PoE – which one do I use?

- The different standards are concerned with the power delivery capability from a single PoE router/switch output – the VR1 is classed as a low power device and will work with all standards – PoE, PoE+, and PoE++. All of these systems run at approx. 48V output.

### Where can I purchase a network switch / router with PoE?

- These are very common, and are available from many online shops. They are generally inexpensive and work very well, but we obviously cannot guarantee that every model available will work, so we advise purchasing one from a leading manufacturer (such as Netgear, Belkin, Cisco, TP Link), as we have tested several of these devices, and found they work perfectly.

### Do I need special Ethernet cables for PoE use?

- No. Any good quality CAT5 (or greater) standard Ethernet cables will work.

### What happens if I accidentally connect a standard Ethernet device to the PoE port?

- Nothing. The electrical power is sent down 'reserved' wires, in the Ethernet cable, that are not normally used and will not be connected, so a PoE port can be used the same as a conventional port.

### The VR1 wall panel appears to turn itself off when not being used - Is this normal?

- Yes. The VR1 will go into standby mode, when it is not being used. The device is functioning perfectly normal, and will immediately 'wake-up' when up when any control is used. This feature is designed to save power, and also to extend the life of the LCD display and LEDs.

### MAINTENANCE

The VR1 will require very little routine maintenance. Cleaning the panel and switches should only be done with a cloth lightly dampened with water only! The use of chemical or abrasive cleaners may damage the paint finish. Do not spray cleaner onto the LCD screen - spray onto cloth and then clean scree if required.

### SERVICING

There are no user serviceable parts within the unit! Please contact us to arrange returning any units to us that require servicing or repairing.

### WARRANTY

This product comes with a warranty against defects in components and workmanship only, for a period of five years from the date of shipment to the customer. During the warranty period, NST Audio will, at its discretion, either repair or replace products that prove to be defective, provided that the product is returned, shipping prepaid, to an authorised NST Audio service facility.

Defects caused by unauthorised modifications, misuse, negligence, act of God or accident, or any use of this product that is not in accordance with the instructions provided by NST Audio, are not covered by this warranty.

This warranty is exclusive and no other warranty is expressed or implied. NST Audio is not liable for consequential damages.
